THE EVANGELICAL COVENANT CHURCH**

- Disclosure form, baptismal statement, and criminal record screening report must be on file at the Ordered Ministry office before license is granted.
- The Board of the Ordered Ministry recommends an interview by your conference committee on ministerial standing every three years for as long as you hold this license.
- This license requires mandatory participation in the Covenant Pension Plan (if serving a Covenant church).
- If you have not completed one year at North Park Theological Seminary you will need to apply for Covenant Orientation. (Persons who are age 60 and over are exempt from the full Orientation Program as a requirement for this license.)
- This license requires completion of graduate-level survey courses in the foundational areas of systematic theology, Old Testament, New Testament, and church history. Within eight years of receiving your first-time license, you must show proof of completion of these four foundational courses. If you have not already completed these courses, you must complete them at North Park Theological Seminary, unless you are actively enrolled in a degree program at another ATS-accredited seminary and intend to take the courses at that seminary. Send official transcripts to Ordered Ministry.

1. **Interim Ministry License.** Recommendations "A" and "C" to be completed on the back of this form. Valid until June 30. This license may be granted in the interim between Annual Meetings, and requires a favorable interview with the conference committee on ministerial standing.
2. **First-time Ministry License recommended by a regional conference ministerial association.** Recommendations "A" and "B" to be completed.
